

## Frequently Asked Questions about Lutheran Social Services of Illinois (LSSI)

### 1. What does LSSI do?

LSSI is the largest statewide social service agency in Illinois. It is the social ministry organization of the three Evangelical Lutheran Church in America (ELCA) synods in Illinois. We offer services for the state's most at-risk residents including:

- Foster care
- Family support services
- Head Start and child care
- Mental health services
- Alcohol and drug treatment
- Home care for seniors
- Affordable senior housing
- Residential programs for people with developmental disabilities
- Programs that help incarcerated individuals remain connected to their children
- Employment skills school for those recently released from incarceration
- Help for families and individuals impacted by natural disasters

### 2. Where is LSSI located?

Our administrative offices are in Des Plaines, but LSSI offers dozens of programs at sites across the state.

### 3. How long has LSSI been around?

LSSI began in 1867 as an orphanage for children who lost their parents in the cholera epidemic. We celebrated our 150<sup>th</sup> anniversary on October 31, 2017.

### 4. What is LSSI's mission?

Responding to the Gospel, Lutheran Social Services of Illinois brings healing, justice and wholeness to people and communities.

### 5. Does a person have to be Lutheran to receive services from LSSI?

No – LSSI serves all people without regard to race, religion, ethnicity, gender or sexual orientation.

### 6. How many people does LSSI serve?

- In FY17 LSSI served almost 50,000 people.
- LSSI is the largest provider of foster care in Illinois, caring for 10% of all children in foster care in the state. (over 2,000 children served annually)
- In FY17, LSSI provided affordable housing for 1,315 seniors.

## **7. What role does the state of Illinois play in LSSI's services?**

The state of Illinois contracts with LSSI to provide services to state residents, including children in foster care and people living with physical and mental disabilities. LSSI receives payments from the state as required by court orders and federal mandates.

## **8. What is Lutheran Disaster Response (LDR)?**

LDR-IL is a program of LSSI that responds to communities within the state that have been affected by disaster; its focus is on long term recovery. We also offer workshops in emergency preparedness for congregations and individuals.

## **9. Does LSSI have affiliations with other organizations?**

LSSI is a social service ministry of the Evangelical Lutheran Church in America (ELCA). It is a ministry partner of the three ELCA synods in Illinois: the Metropolitan Chicago Synod, the Northern Illinois Synod and the Central/Southern Illinois Synod.
